Method used: HPLC, column LiChrospher 60 RP-select B, 250x4mm (5 µm); pre-column 4x4mm RP-select B (5 µm).

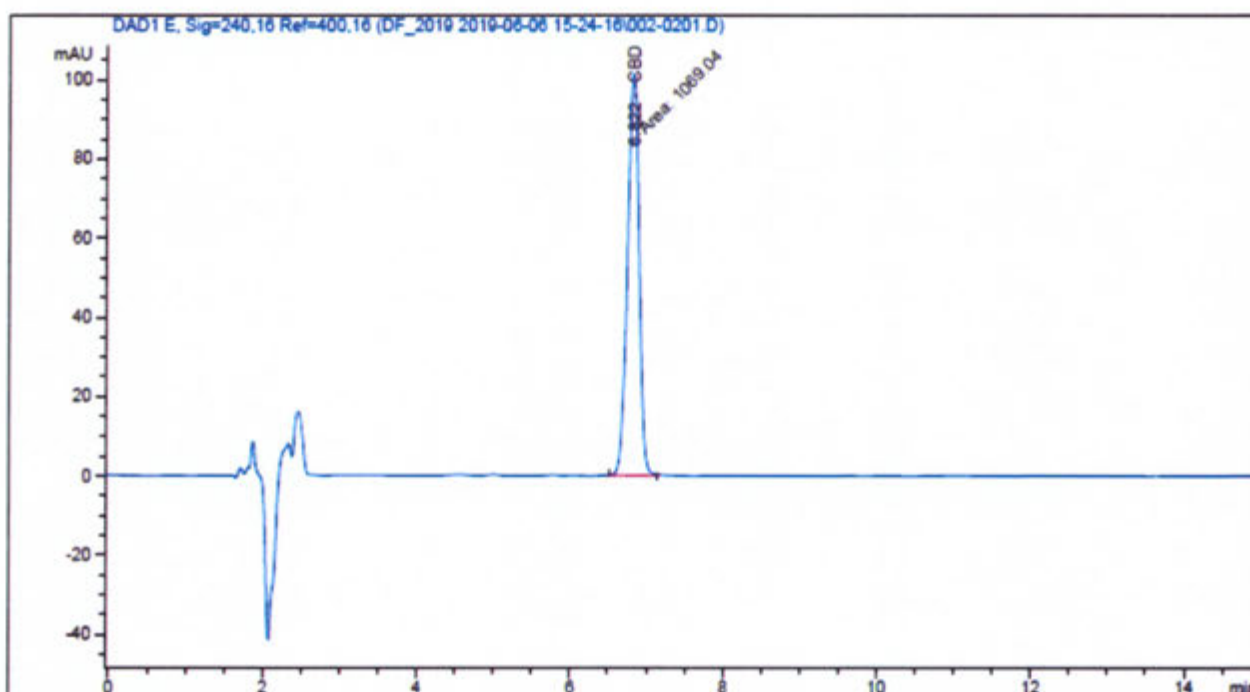
